### 1 About Group Development Pakistan (GDP.)

Group Development Pakistan (GDP.) is a Civil Society Organization registered under the Societies Registration Act, 1860, working on protecting and promoting child rights and strengthening child protection and justice with children across Pakistan. GDP. believes in a democratic and humanistic society in which the most important stakeholders -children- are acknowledged, respected, and protected from all forms of violence and discrimination. GDP. follows a holistic, creative, participatory, inclusive, eco-friendly, child-focused, and human rights-based approach.

#### 2 Background

Promoting and Protecting the Welfare of Women and Girls (PPWWG) by improving the structural, institutional and socio-cultural response to sexual and gender-based violence (SGBV) in Pakistan is a project being implemented by Group Development Pakistan. The project focuses on better promoting and protecting women and girls' welfare through a closer partnership between the state, civil society, and media to provide ethical and quality support in line with SDG 5 and 16.2, the UNCRC., CEDAW, ICCPR and other international treaties impacting girls and ratified by the country.

## **3** Objective of the consultancy

The overall purpose of the consultant is to train Caregivers in Peshawar, Punjab, and Karachi on Psycho-social support for Child Victims of GBV. The training session will be for 2 days at each location. The participants at the training will primarily be representatives from provincial state child protection institutions in KP, Punjab, and Sind. However, teachers and other relevant stakeholders may also participate in the training activities. The consultant will be responsible for developing and drafting the training manual.

#### 4 Tasks

The consultant will be responsible for performing the following tasks including but not limited to:

- Developing and draft manual content for Training on Psycho-Social Support (PSS), including agenda/schedule, PPT presentations/modules, pre-test questioners (in MCQs) form, and Handouts in close Liaison with GDP s Capacity-building Team and under its senior technical advisor.
- Deliver 2-days training sessions in the locations mentioned above using cognitive and

participatory approaches.

- Evaluate the training qulaity and efficiency using the pre/post-test questioners.
- Submit a final report for each conducted training within a week, as per GDP's format.

#### **5** Key Deliverables

The consultant is responsible for producing and submitting the following key deliverables:

- Delivery of Two day training sessions at each location
- Content and Manual for the Training
- Pre/Post test for the evaluation of the Training
- Final report submission.
