Subject: Call for Quotation

Group Development Pakistan (GDP) is soliciting quotations from interested parties/companies for the procurement of awareness plates for the green flag campaign. The requirements and terms and conditions of the awareness plates are given below;

1. The design of the plate is given below, and editable file can be downloaded from the link given below:

2. Quantity: 1,000 (kindly quote prices as per the stated quantity)
3. **Preference 1:** Acrylic plate with UV printing - size of the plate (Height x Width): 6 x 9 inches - thickness 5mm
4. **Preference 2:** Steel plate with UV Printing - size of the plate (Height x Width): 6 x 12 inches - thickness 24 gauge SS material
5. Please note that interested companies are encouraged to submit sample designs for both preferences (1 & 2) mentioned above with the quotations. GDP will not bear any cost for participating in this procurement or for submitting the samples.
6. All taxes and duties shall be paid by the supplier as per prevailing Tax Laws of Govt. of Pakistan, Federal and/or Provincial with absolutely no compensation by the Group Development Pakistan.

7. Payment shall be made in the form of cross cheque and withholding tax shall be deducted at the time of payment.
8. Prices quoted inclusive of all taxes and shall be delivered to GDP's office in "**Islamabad**".
9. This Call for Quotations shall be awarded on the basis of the lowest price offered compliant with all the requirements.
10. In the case that the quotation submitted by the first ranked bidder does not meet the requirements set out in this Call for Quotations, the submission will be deemed to have failed to qualify and the evaluation process is re-iterated with the next best-ranked bidder in accordance with the results of the process, until there is a match to compliance and no quotation is found to be in compliance with the requirements.
11. GDP is not bound to accept any of the submitted quotations and has the right to refuse in part or in full any or all the submissions, even the most advantageous, without giving reasons to do so. The lowest priced quotation submitted by the bidders shall not necessarily be an indicator of best value for money and may be refused.
12. Payment will be made within **one week** of acceptance of delivery of **plates** and on subsequent submission of the invoice to GDP.
13. Interested parties may submit their priced quotations not later than Monday, 25 July 2022 at the office of GDP 'Office # 11-18, Lower basement, Magnum Arcade Northern Strip, 2, F.E.C.H.S. FECHS E 11/2 E-11, Islamabad, Islamabad Capital Territory'
14. The awareness plates must be delivered in full within 15 days, or earlier if possible, from receipt of Purchase Order.
15. GDP reserves the right to increase or decrease the quantity of required items or decide not to order an item depending on the requirement.
16. While submitting your quotation in hard form, clearly mention on the envelope **"Quotation for Awareness Plates"**.
