

Terms of Reference (ToRs) to Update training module for capacity building of Nikah Registrars, Nikah Khawans and UC secretaries- Punjab.

Consultancy:

Update the training module for capacity building of NIkah registrars, Nikah Khuwans and UC secretaries and Trainings sessions facilitation of 80 Nikah registrars and oversight authority members in Punjab on newly developed Nikah Registrar certification criteria and Nikah oversight mechanism.

Group Development Pakistan (GDP) is a Civil Society Organization registered under the Societies Registration Act of 1860, working on protecting and promoting child rights and strengthening child protection and Justice with children across Pakistan. GDP believes in a democratic and humanistic society in which the most important stakeholders -childrenare acknowledged, respected, and protected from all forms of violence and discrimination. GDP follows a holistic, creative, participatory, inclusive, eco-friendly, child-focused, and human rights-based approach.

1 Background

Pakistan ranks 6th globally in terms of the number of girls married before the age of 18. Child marriage not only deprives girls of their right to a safe and healthy childhood but also compromises their access to quality education, economic opportunities, and social empowerment. The impact extends to health, nutrition, fertility, child mortality, educational attainment, labor force participation, women's agency, and gender-based violence.

The consultancy focuses on reforming the marriage registration process in Punjab by enhancing the capacities of Nikah registrars to ensure accurate documentation and adherence to legal requirements. This will strengthen the women's position in possessing the documentary evidence necessary for various legal matters, including inheritance, property rights, and divorce proceedings. This initiative will strengthen the documentary evidence to combat issues, including the denial of women's and children's rights.

2 **Objective of the consultancy**

The assignments aim to:

- Develop a clear and legal base of knowledge of relevant laws, proper documentation, and ethical conduct for Nikah registrar for marriage registration.
- Establish a robust oversight system to monitor Nikah Registrars' performance, address issues, and ensure compliance with legal requirements.
- Training of 80 Nikah Registrars and Oversight body members for the newly developed mechanism.

3 Tasks

The consultant will be responsible for performing the following tasks, including but not limited to:



- Revision of training materials (Already developed for same stakeholders in KPK) including training agenda, Manual, IEC materials, handouts, presentation and other helping materials.
- Conduct 10 two-day Training sessions of 200 target Nikah Registrars and oversight authorities on CM registration, Nikah registrar certification, and oversight mechanisms for the pilot phase.
