# Who We Are

Group Development Pakistan (GDP) is a Civil Society Organization registered under the Societies Registration Act, 1860 working on protecting and promoting child protection and justice with children across Pakistan. GDP believes in a democratic and humanistic society in which the most important stakeholders – children – are acknowledged, respected and protected from all forms of violence and discrimination. GDP follows a holistic, creative, participatory, eco-friendly, child-focused, and human rights-based approach.



# Project: Promoting and Protecting the Welfare of Women and Girls (PPWWG)

# Project Brand Name: Urdh Ja! (Fly high!)

The project aimed to achieve the following objectives: O1: Progress towards improved regulatory framework to counter VAC & GBV in Pakistan, such as but not limited to child marriage and forced conversion; O2: Improved capacities of justice actors, media, caregivers, children/youth and community to prevent and respond to VAC & GBV in Pakistan, such as but not limited to child marriage and forced conversion; O.3: Improved awareness of community members, CSOs, children and youth on how to prevent and respond to VAC and GBV in Pakistan, such as but not limited to child marriage and forced conversion.; O.4: Increased local and international basis of evidence for a youth-led & participatory transformative process to counter GBV, including but not limited to Child marriage and forced conversion.

#### **Key Achievements:**

- Capacitated 1,344 stakeholders (418 women, 798 men, 71 girls, and 57 boys), including judges, probation officers, police, lawyers, teachers, media persons, and caregivers, on Child Rights, Child Protection, and Justice with Children in six major districts of Pakistan: Islamabad, Rawalpindi, Peshawar, Lahore, Karachi, and Quetta.
- Sensitized 4,756 community members (2046 women, men 1243, 711 girls, and 689 boys) in three districts of Pakistan: Islamabad, Peshawar, and Lahore.

### Project: Protecting and Promoting the Children's Rights in Pakistan (PPCRP)

The project aimed to achieve the following objectives: O1: Increased awareness of child sexual abuse and state obligations to protect child rights; O2: Improved Capacity Building of justice actors to investigate, prosecute, and prevent Child Sexual Abuse; and O3: Expand access to support services for victims and their families and improve quality of legal services available to victims.

#### **Key Achievements:**

- 1. Developed 1 training curriculum for justice sectors actors of international standards.
- 2. Capacitated 174 judges and prosecutors (27 women, 147 men) on Child Protection laws.
- 3. Capacitated 60 police officials (2 women, 58 men) on child protection laws.
- 4. Capacitated 165 legal aid lawyers (64 women, 101 men) to take on CSA cases in court.
- 5. Sensitized 736 community members (354 women, 265 men, 73 girls, and 44 boys) through 38 community members on Child Protection.

# Consultancy: Capacity-building of Media for Improved Research and Reporting on Child Labor in Pakistan-International Labor Organization.

The assignment aims to achieve the following objective: to eradicate the worst forms of child labor and exploitation and strengthen child protection. By equipping local media with the tools to create content that is not only informative but also aligned with ethical standards, the assignment seeks to catalyze a positive shift to denounce child labor in its all forms. Moreover, the enhanced understanding of international commitments and national regulations pertaining to child labor will enable the media to scrutinize and hold accountable those responsible for its perpetuation effectively. In turn, this will contribute to a more informed and vigilant society that actively participates in eradicating child labor.

- Developed a training manual for training media officials on child labor, relevant international commitments, national legal/policy framework, and major developments.
- Capacitated and mentored 78 media officials (31 women, 47 men) on ethical and quality reporting on child labor in Pakistan.
- Developed two short and explanatory animated videos on 'ILO Worst Forms of Child Labor Convention (No. 182)' and 'ILO Minimum Age Convention (No. 138).
- Developed a glossary of child-sensitive words that could be used for ethical and quality reporting on child labor.

## Project: Improving Women & Girls Police Station in G-7 Islamabad

The project aimed to create a specialized and welcoming environment within the G-7 Islamabad police station. By renovating and transforming this facility into a women's police station, the project ensured a safe, supportive, and empowering space for women and children.

The primary objective of this initiative was to address the unique needs and challenges faced by women and girls when seeking assistance from law enforcement agencies. The project envisioned a comprehensive renovation that includes structural modifications, security enhancements, and the incorporation of design elements that prioritize comfort, privacy, and accessibility in a conducive manner.

# Project: Emergency Food Relief and Children Dignity Kit Distribution to Flood Affected Families.

The project was to provide relief and support to families affected by flooding in the Rajanpur District, Punjab, and Dera Ismail Khan District, Khyber Pakhtunkhwa. This initiative seeks to alleviate the immediate challenges faced by flood-stricken families, with a special focus on maintaining the dignity of children, particularly young girls. The primary objective of this project is to provide essential relief to flood-affected families, ensuring their access to food and basic hygiene items. Additionally, the project aims to uphold the dignity of children by distributing kits containing educational and recreational materials, promoting normalcy and mental well-being during these challenging times.

- 500 packages of Ration Pack and Children Kits to 500 households in Rajanpur District, Punjab Province.
- 550 packages of Ration Pack and Children Dignity Kit to 500 households in Dera Ismail Khan District, Khyber Pakhtunkhwa Province.

# Project Title: Counter Child Labor Through Empowering Government Institutions & Communities in Pakistan (4163)

The project was based on a partnership between Solidar Swiss and Group Development Pakistan (GDP) and aimed to foster child welfare at the federal level in Islamabad Capital Territory (ICT) through improved child protection, health, and education for marginalized boys and girls. To this end, the project envisaged the following outcomes: Outcome 1: The quality of the state child welfare mechanism in Islamabad is strengthened through improved policies, systems, and procedures aligned with international standards; Outcome 2: Improved welfare for targeted vulnerable boys and girls aged 5 to 14 in E-11 slum and in two child welfare institutions of Islamabad; Outcome 3: Police, community members, children and youth engagement on child welfare strengthened to advocate for improved prevention and protection of children against violence (especially child sexual abuse) and health hazards.

- Capacitated 28 representatives of CSOs and 5 CPI staff members (10 women, 22 men) on ICT Child Protection Act 2018.
- The CPI Committee approved the Operational Framework for CPI developed by GDP on the request of MOHR.
- Developed and delivered a Child Protection Policy (CPP), including case management and a referral mechanism, and a set of minimum standards for alternative care and SOPs.
- Capacitated 19 police officials (6 women, 13 men) on ICT Child Protection Act 2018.
- Capacitated 32 CSOs' representatives (10 women, 22 men), including 5 CPI staff members on ICT Child Protection Act 2018.
- Capacitated 48 staff members (26 women 22 men) of ICT CPI, ICT Women Crisis Center, and ICT Model Village on ICT Child Protection Act, 2018.
- Sensitized 538 children (244 girls, 294 boys) on child rights.
- Sensitized 980 children (444 girls, 536 boys) on self-protection from CSAE.
- Sensitized 966 children (431 girls, 535 boys) on online safety.
- Sensitized 218 children (76 girls, 142 boys) on WASH/COVID19 prevention.
- Sensitized 243 children (112 girls, 131 boys) on burn prevention and first aid response.
- Conducted 3 LSBE sessions with 171 pupils (48 girls, 123 boys) of three seminaries in ICT.
- Developed and distributed 2932 IEC materials and booklets, including UNCRC, Digital Safety, Mai aur Meri Mehfooz Dunya, Achi Adatain, Leaflet on Emergency Numbers, Leaflet on COVID19 Prevention, and Faiz aur Faiza.
- Sensitized 206 community members (10 women, 181 men, 13 girls, 02 boys) on child welfare and importance of education for all.
- Sensitized 47 community members (2 girls, 45 women) on personal, domestic and environmental hygiene/COVID19 preventions.
- Redressed and/or referred 13 distress calls seeking assistance or guidance through community-based Grievance/Complaint, Redressal, Feedback & Referral Mechanism.
