Objective of the consultancy

Group Development Pakistan (GDP), in collaboration with UNFPA and with support from FCDO under the AAWAZ II flagship project, is implementing an initiative to strengthen policy and legal frameworks addressing gender-based violence (GBV) in Pakistan. As part of these efforts, GDP is supporting evidence-based reforms in the Islamabad Capital Territory (ICT) by generating quality data and analysis on GBV, including child marriage and domestic violence.

GBV continues to undermine the safety, dignity, and rights of women and children in Pakistan. Despite increased legal protections, gaps persist in data availability and systematic trend analysis, including at the ICT level. To inform future reforms and advocacy, GDP seeks to produce a comprehensive research report analyzing GBV trends and consequences using secondary data sources, including government records, institutional reports, and available case files. This research will provide a legal and policy lens on one-year GBV trend and consequences, with a focus on child marriage and domestic violence, and propose actionable recommendations for countering GBV. The report will serve as a resource for law and policymakers, civil society actors, academia, and development partners.

Scope of Work

GDP is seeking a legal consultant who will be responsible for the following work:

- 1. **Methodology, Desk Review & Data Compilation**: Co-develop an inception report to present the secondary data-based research methodology; Collect and review existing GBV-related data from government records over a year.
- 2. **Trends Analysis**: Conduct a one-year trend analysis of GBV and child marriage cases in ICT, disaggregated by parameters that will have been previously defined and jointly approved; identify patterns, systemic challenges, and multisectoral consequences, submit the draft report to the relevant stakehodlers for feedback, incorporate it and finalise.
- 3. **Recommendations:** Develop gender-responsive and inclusive actionable recommendations to strengthen legal, institutional, and policy prevention and responses to GBV and child marriage in ICT; highlight measures specifically addressing child marriage and domestic violence.
- 4. Technical Inputs to Report Development: Provide GDP's Senior Technical Advisor with



consolidated data sets, analytical notes, and findings to support the co-development of the inception and final research reports.

5. Submit a consolidated report to the project team at the end of the consultancy period.
