Terms of Reference (TOR) Consultancy – Draft rules of Balochistan Child Marriage Restraint Act 2025

Who we are: Group Development Pakistan (GDP) is a Civil Society Organization registered under the Societies Registration Act of 1860, working on protecting and promoting child rights and strengthening child protection and Justice with children across Pakistan. GDP believes in a democratic and humanistic society in which the most important stakeholders – children - are acknowledged, respected, and protected from all forms of violence and discrimination. GDP follows a holistic, creative, participatory, inclusive, eco-friendly, child-focused, and human rights-based approach.

Background

Group Development Pakistan (GDP), in collaboration with UNFPA, is committed to advancing legal and policy reforms that protect the rights of women and children, particularly adolescent girls. A key priority is supporting the effective imple up mentation of the Child Marriage Restraint Act 2025 (CMRA) in Balochistan. While Pakistan has made progress in addressing gender-based violence and child marriage through legislative reforms, the absence of comprehensive rules under the CMRA in Balochistan continues to hinder enforcement, accountability, and access to justice. Developing these rules is essential to operationalize the law, clarify procedures, strengthen institutional roles, and ensure the protection of vulnerable girls across the province. To support this critical reform, GDP seeks to engage a legal consultant to lead the development of the CMRA Rules for Balochistan. The consultant will review existing legal frameworks, draft the required rules, and ensure they are evidence-based, constitutionally sound, aligned with international human rights commitments, and informed by best practices. The consultant will work closely with the Social Welfare Department and the Director Human Rights and will collaborate and consult with the Law Department and other concerned departments for the development of the Rules of Business. Throughout the assignment, and particularly while engaging with government departments, the consultant will coordinate with and take guidance from the UNFPA Program Coordinator for the duration of the consultancy.

Scope of Work

GDP is seeking one individual consultant who will be responsible for the following work:

- 1. **Desk Review:** Review the Child Marriage Restraint Act and other existing drafts of the concerned GBV related laws and child marriage rules, conduct a comparative analysis with other provinces, identify gaps and inconsistencies, and areas for improvement.
- 2. **Development of Updated Drafts:** Prepare draft rules incorporating the findings identified through the desk review and aligned with constitutional and international standards.

- 3. **Stakeholder Engagement:** Share the updated drafts with relevant stakeholders (government, CSOs, legal experts, and development partners) for feedback; document and analyse stakeholders' inputs for incorporation.
- 4. **Finalization:** Incorporate stakeholders' feedback and finalize the legal drafts, then submit a clean version and a tracked-change version, with an accompanying explanatory note highlighting revisions made.
- 5. Submit a consolidated report to the project team.
